2024-2026 Texas Early Learning Strategic Plan Goals

Family Access, Navigation & Engagement	Goal 1	Families can easily meet their basic needs and access the early learning services, programs, and resources they need, and are meaningfully engaged to provide feedback on services.
Workforce Recruitment, Retention & Support	Goal 2	The early learning workforce is well-paid, trained and supported; can reach and obtain the professional development resources they need throughout their careers; and is large enough to meet Texans' needs.
 Local Systems & Partnership Building	Goal 3	Local early learning systems are well-coordinated, appropriately resourced, and successfully support the children and families in their communities.
 Integrated Data & System	Goal 4	State early learning system entities are collaborating to make family- and data-informed decisions to improve services, programs and resources for children and their families.

Local Systems & Partnership Strategies

Strategy 3.1: Provide educational and informational support to local partnerships to help communities make informed decisions.

Local Systems & Partnership Strategies

Action 3.1.1: HHSC will continue offering sub-grants to existing Family Support Services (FSS) programs to help local communities focus on community needs. Grants can also be used to hire a full-time staff member for coalition work.

- PDG supports FSS initiatives to establish or enhance centralized access and resource navigation in local communities. Centralized access connects families and professionals to a network of community resources that support young children and their families in their local community.
- Centralized intake and referral systems launched or expanded in seven communities:
 - Brazos, Burleson, Grimes
 - Dallas, Rockwall, Kaufman
 - Ector, Midland
 - Tarrant, Wise
 - El Paso
 - Galveston
 - Harris
- Centralized access and resource navigation also supported through new Help Me Grow communities:
 - Hays, Caldwell
 - Montgomery
 - Colorado, Fayette
 - Nueces, San Patricio

Local Systems & Partnership Strategies

Action 3.1.1: HHSC will continue offering sub-grants to existing Family Support Services (FSS) programs to help local communities focus on community needs. Grants can also be used to hire a full-time staff member for coalition work.

- This quarter, awardees addressed more than 950 calls through their centralized access services and connected families to relevant providers and resources. More than 200 families were connected to early childhood programs specifically through these centralized access services.

Action 3.1.2: TWC and TEA will continue to support statewide staff working towards prekindergarten and child care partnerships.

Data & System Coordination Strategies

Strategy 4.1: Develop an ECIDS to strengthen data sharing across agencies and better inform state-level policy and program improvement.

Strategy 4.3: Increase alignment and coordination across agencies to improve family access, navigation, and engagement.

Data & System Coordination Strategies

Action 4.1.1: ECIW will develop a cross-agency data governance plan, including crafting an objective, framework, roles, and responsibilities, and documenting relevant privacy laws and regulations.

Action 4.1.2: ECIW will review existing statutory and legal requirements and develop required data sharing agreements for the priority business case(s) and a process for updating interagency agreements.

Proposed "Strategic Plan Workgroup"

- Suggested charge of work group is to advance all Texas Early Learning Strategic Plan action items assigned to the Texas Early Learning Council, including:
 - Prioritize the actions, starting with Workforce related actions (Goal 2)
 - Determine next steps on priority actions and assign owners
 - Provide updates on progress at quarterly TELC meetings
- Responsibilities
 - Meet 1 to 2 times per month virtually through 2024 and 2025
 - Advance assigned work in between meetings
- Membership
 - TELC members or their designated representatives
 - Revisit membership at end of 2025

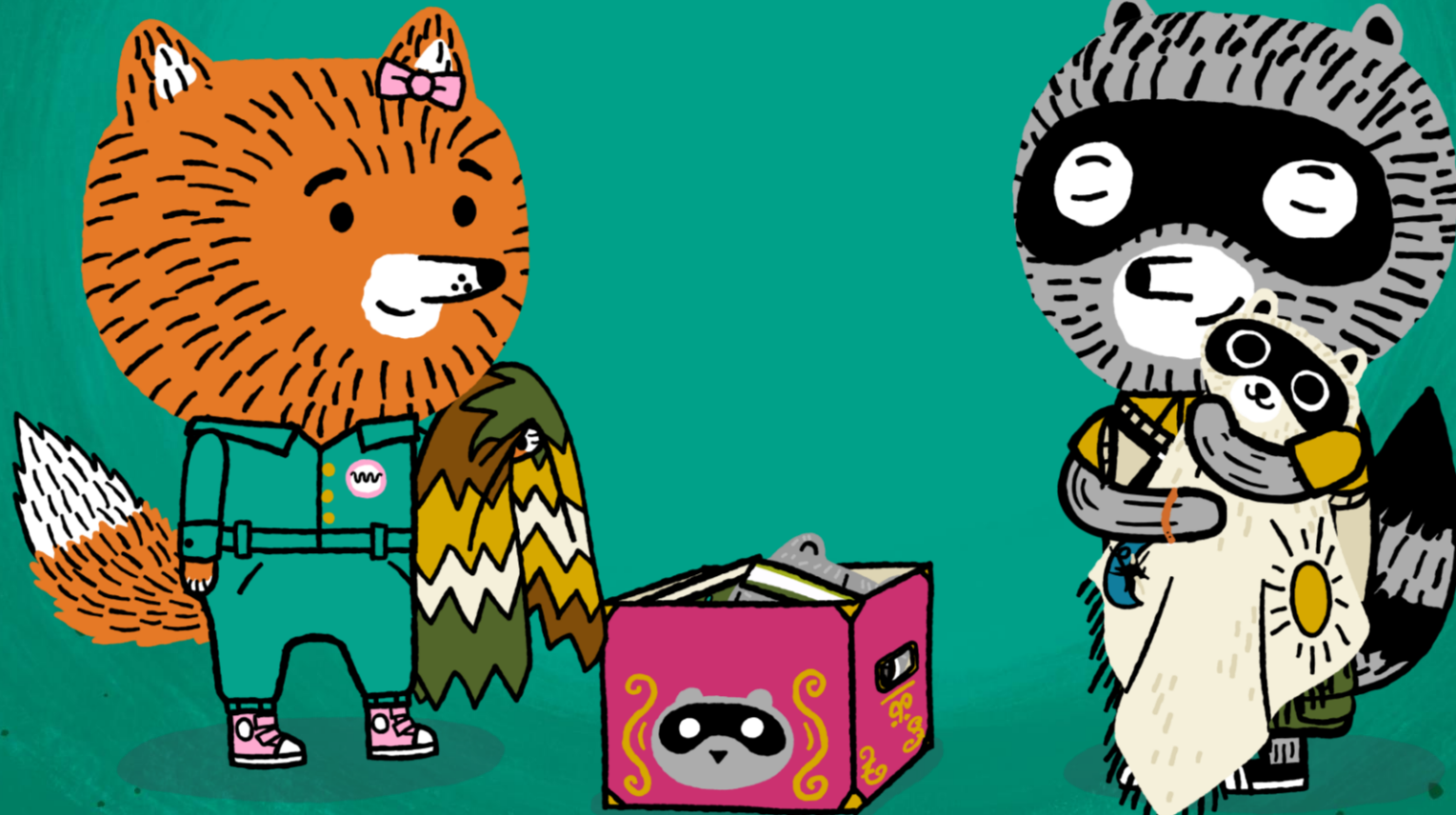

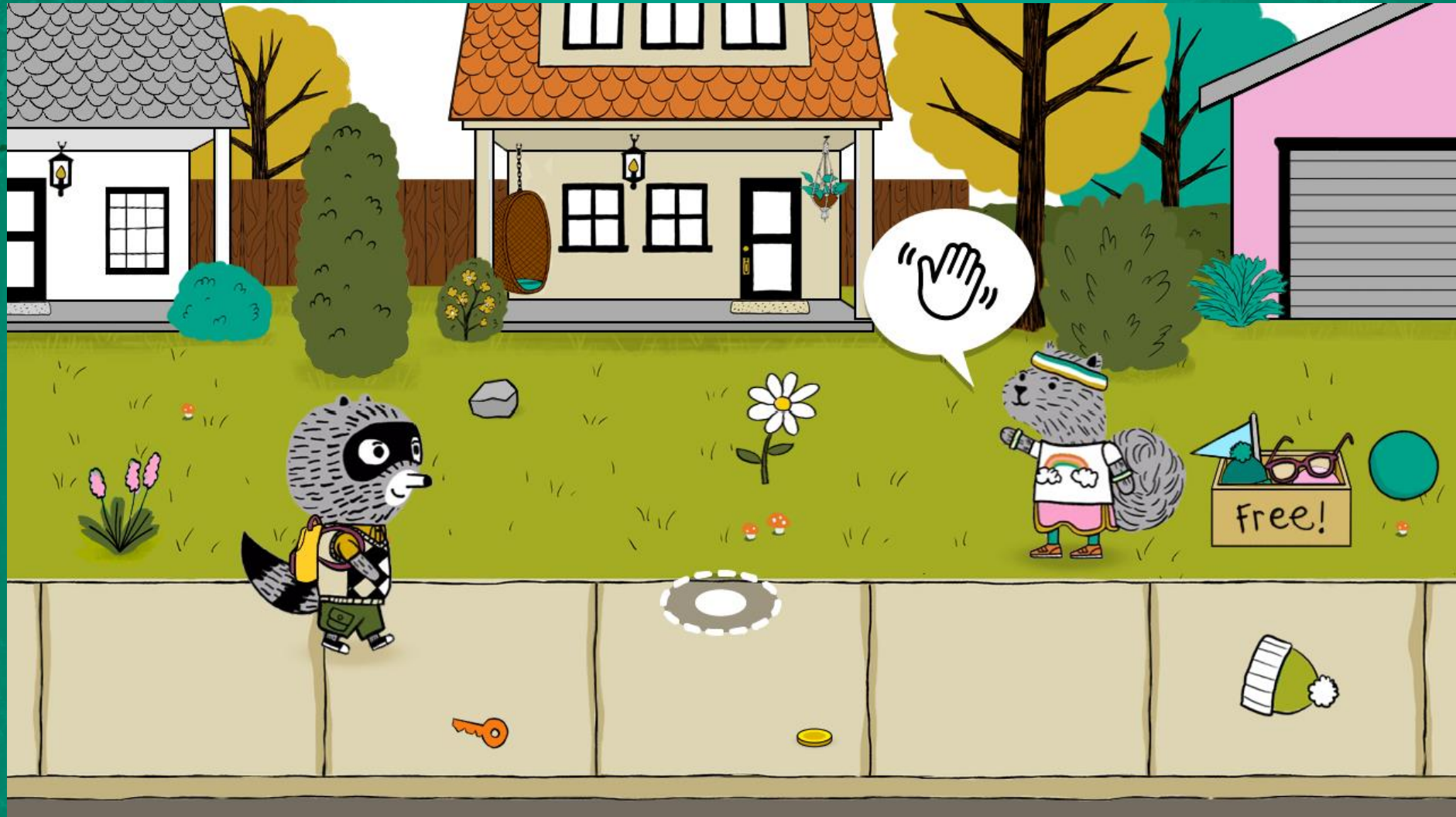

TWC Updates



Child Care Services (CCS) Update

- Increases in CCS Payment Rates
 - FFY20: base rates at the 30th percentile
 - FFY23: base rates at the 75th percentile
 - FFY24&
FFY25: base rates at least at the 75th percentile
base rates may be increased based on Cost of Quality
- Increases in CCS Local Funds for Quality Improvement
 - FFY22, and prior years: 2%
 - FFY23: 4%
 - FFY24: 4%
 - FFY25: 6%

Child Care Services (CCS) Update

- Increases in Texas Rising Star Mentors/Assessor Funding
 - FFY19 - \$9.6 million
 - FFY20 - \$10.3 million
 - FFY21 - \$10.5 million
 - FFY22 - \$17 million
 - FFY23 - \$31.9 million
 - FFY24 - \$37 million
 - FFY25 - \$39 million
