Cathi Arwood (Texas Workforce Commission) shared details about the 2025-2027 Child Care Development Fund State Plan and opportunities for stakeholders to provide feedback, including input meetings and surveys.

Meghan Young shared about upcoming professional development opportunities for ECI direct service personnel including the Series for Meaningful Interagency Learning and Education (SMILE) and Genetics webinar series. ECI is continuing their PEER network, with over 400 members. ECI is preparing for the final of four Creating Connections conferences focused on inclusive classrooms for early childhood care and education professionals.

Sarah Abrahams gave an update on the transition of Prevention and Early Intervention (PEI) services to Health and Human Services Commission in September and renaming the division Family Support Services (FSS). There is a lot of work going into making the transition a smooth and timely one. PEI expansion funding, received in last legislative session, is being used to expand existing and established programming and to expand geographic reach across the state. To date, more than \$12 million has been granted to existing communities for new services or targeting new populations.

Stephanie Rubin and Alec Mendoza (Texans Care for Children) shared results of the latest ECI Provider surveys and mentioned a public report coming soon.
